Contest Rules

"Win a Wi-Fi Nest Protect smoke alarm"

The contest "Win a Wi-Fi Nest Protect smoke alarm" is organized in Québec by the Organisme d'autoréglementation du courtage immobilier du Québec (OACIQ) as part of the 2016 National Home Show.

1 ELIGIBILITY

The Contest is open to all residents of the province of Québec who are at least 18 years of age at the time of entry.

Employees, agents and representatives of the OACIQ, their family members and those domiciled with them are not eligible to participate. Holders of a broker or agency licence issued by the OACIQ are also excluded from this Contest.

2 CONTEST TERMS AND CONDITIONS

No purchase required.

Anyone may enter the contest throughout the duration of the National Home Show 2016 starting March 4, 2016, at 11:00 am until March 13, 2016, at 6:00 pm, according to one of the two (2) following methods:

- a. By visiting the OACIQ booth (No. 1730) to use the Key Survey application accessible through the computer equipment provided for this purpose and complete an electronic entry form indicating the person's first name and last name, phone number and email address; or
- b. By viewing the OACIQ page and clicking "like" when you log in to your Facebook account, making sure to maintain this status until the date and time scheduled for the designation of winners.

Regardless of the method chosen, entry to the contest is limited to only one (1) per person for the duration of the National Home Show 2016.

3 PRIZE

The prize offered is a Wi-Fi Nest Protect carbon monoxide and smoke alarm valued at \$126 (taxes included). The prize must be accepted as awarded and cannot be replaced by another prize. A total of three (3) identical Nest Protect alarms to be awarded.

4 AWARDING OF PRIZE AND SELECTION OF WINNER

On March 17, 2016, at 2:00 pm, at the OACIQ head office located at 4905 Lapinière Boulevard, Suite 2200, Brossard, **three (3) entries** will be drawn at random from all entries received. The draw will take place before two (2) witnesses.

To be declared the winner and be eligible to receive the prize, the participant whose entry is drawn at random must be reached by telephone or email by the OACIQ within seven (7) working days following the draw and must have correctly answered the following mathematical skill-testing question: $(2 \times 8) + 15 =$ ____.

If the participant whose entry was randomly drawn can be reached, the OACIQ will send him/her the prize at the address provided by the participant.

If the participant whose entry was randomly drawn does not fulfill any of the conditions of this contest or if the OACIQ is unable to reach him/her during the specified period, he/she will automatically be declared non-eligible and will not be entitled to claim the prize. In this case, the OACIQ will randomly draw another entry among all remaining entries. The same conditions regarding the awarding of the prize and the selection of the winner will then apply.

The OACIQ is not responsible for late, misdirected or delayed entries.

The name of the three (3) winners will be advertised on the OACIQ website.

In addition, the OACIQ is released from any liability for any damage arising from participation in the Contest or from the awarding, use or misuse of the prize.
